CONSENT AGENDA

The items on the consent agenda were:

BOND PROJECTS

<u>Fire Apparatus</u> The apparatus are in Colorado and are currently in post-delivery inspection. The apparatus should be here soon and in-service before the next board meeting.

<u>Buildings</u> Station 83 is complete and the certificate of occupancy received. The Station 83 construction came in under budget and the district will receive roughly \$82,000 returned.

<u>Training Ground</u> The Master Projects list is being revised. There is approximately \$1.6 million available for the training ground construction. The project should break ground in May 20021.

NEW BUSINESS

Posting Places Resolution

Health Reimbursement Account Resolution

MOTION: made to approve Resolution 2021-002, A Resolution of the Board of Directors of the Carbondale & Rural Fire Protection District Establishing a Health Reimbursement Arrangement (HRA) Plan. It carried and passed unanimously.

Employee Length of Service Awards An Employee Length of Service Awards Program has been developed. This is a form of employee retention. It was noted a monetary benefit would be paid to employees on every 5th year of employment when being recognized for their service. The first recognition of these employees will be at the February 10, 2021 Board of Directors meeting.

<u>Chief Goodwin Annual Evaluation</u> The members of the Board of Directors each recognized Rob Goodwin for his leadership during 2020. It was noted 2020 was a challenging year with COVID-19 and a challenging fire season that last much longer than normal. The Board of Directors directed the Finance Director to issue a 5% raise to Rob Goodwin for 2021.
